A prime example of this openness to interpretation is the issue that the Outer Space Treaty only prohibits the national appropriation of outer space and the celestial bodies, which leaves open the possibility of an individual or private association lawfully appropriating any part of outer space (Pop 2000, pg. 276). Another example can be seen in Article One of the Outer Space Treaty, which states that outer space is the province of all mankind and that its exploration shall benefit all nations.
