The Rights Of Authors And

Authors' rights have two distinct components: the economic rights in the work and the moral rights of the author. The economic rights are a property right which is limited in time and which may be transferred by the author to other people in the same way as any other property (although many countries require that the transfer must be in the form of a written contract).

People often use the terms "author rights" and "literary rights" to mean copyrights. Copyrights are legal rights that attach to certain types of intellectual property. Copyrights are granted under federal law to authors of creative works at the time of the work's creation in a fixed, tangible form. Authors do not have to apply for or file a copyright.

Author Rights. Overview: Authors retain the copyright to their works until they assign it to someone else. Many times publishers will want authors to assign the copyright to them in exchange for publishing the work. The decision to assign copyright is serious and has many implications.

However, if copyright law were simply a set of rights for authors, their permission would be required before every use, even copying passages by hand. This is not the case. The copyright law, in s103 , makes it clear that copyright is not a tool by which an author may keep others from using the facts or data he or she has collected.
